Further, said owner does hereby expressly stipulate and agree to indemnify and hold forever harmless the City of Bethany, its agents, servants, employees and successors and assigns, heirs, administrators against any loss or from any and all further claims, demands, and actions in law or in equity that may hereafter at any time be made or brought by anyone for the purpose of enforcing a further claim for damages or property on account of said damages sustained in consequence of the release of the vehicle from impoundment.
